- 10. Any other business: DW kindly agreed to take down the goal netting as it was unsightly, serving no purpose and a danger to wildlife; safety concerns were highlighted, namely, the cone is loose on climbing frame, safety rails were down and there was strimmer damage to posts which needed creosoting. NP reported that he had carried out some minor repairs that day for which the Committee expressed their gratitude.
