## 5. Matters Arising

New village sign at Kingcombe Road -Clerk has been in contact with DCC, the request has been passed to Environmental services

Telephone Kiosk – application form for listing almost complete Clerk to continue Highways – The track potholes have been filled but drains are still blocked on right hand side – clerk to contact Rights of Way.

Cllr Miller commented on the amount of mud and slurry on Toller Hill caused by tractors, clerk to write to the farmer concerned.

Also a number of potholes are appearing in passing places on the hill clerk to contact highways. The Parish maintenance unit request sent in December will be acted upon next week, according to Highways Department.

Flooding on road near manor farm – Cllr Ennals to e mail highways to establish responsibility.

6. Possible Proposal for the development of land at 19 High Street –The chairman did stress that this item was for information only - for the council and public.

The landowner spoke briefly of her plans for the development for housing and a purpose built building for use as a Post Office. She has written to the Planning department to enquire what would be allowed. She wanted has asked for co-operation from the Parish Council, requesting that councillors talk openly about the proposed plans. The Chairman made it clear that the Council is not permitted to make any comment for or against the proposed planning application, as no official planning application had been submitted. The chairman suggested the landowner consult WDDC Local plan and that she has an informal discussion with the planning officer at WDDC.

Footpath 21 (Miss Starkey's field) has a very dangerous sleeper crossing a ditch, again a health and safety hazard. (Not yet reported).
